The City of Loganville Mayor and Council met for their regularly scheduled Council Meeting on Thursday, October 13, 2016 at 6:30pm in the Council Chambers. Mayor Dan Curry and Council Members Skip Baliles, Jay Boland, Linda Dodd and Rey Martinez. Council Member Mark Kiddoo was not present.

Mayor Dan Curry called the meeting to order at 6:30pm.

Jimmy Wilson from First Baptist Loganville gave the invocation and Council Member Rey Martinez led the pledge to the flag.

Council Member Rey Martinez made a motion to amend the agenda to include referendum regarding Sunday Package Sales of Distilled Spirits and adopt the agenda. Council Member Jay Boland seconded the motion. Motion carried 4-0.
