

MINUTES
CITY OF LOGANVILLE
Called Council Meeting
Tuesday, November 27, 2012 10:00am
City Hall

The City Council for the City of Loganville held a Called Council Meeting for the purpose of discussing the Intergovernmental Agreement with Walton County Board of Education regarding the proposed school on Bay Creek Church Road. Vice Mayor Dan Curry and Council Members Skip Baliles, Mike Jones, Mark Kiddoo and Michelle Lynch were all present.

Vice Mayor Dan Curry called the meeting to order at 10:04am.

Attorney Richard Calhoun was present and discussed the proposed contract with the Walton County Board of Education regarding running sewer to the proposed schools. There was much discussion regarding the contract and what the Council would like to see in the contract. After much discussion, Council Member Skip Baliles made a motion to have Mr. Calhoun rewrite the contract with all the changes that were discussed to the City of Loganville's final offer to be ready for the December 4th Board of Education Meeting with an expiration date of December 31, 2012. Council Member Mike Jones seconded the motion. Motion carried 4-0.

A motion was made and seconded to enter the executive session with all parties in favor.

Council Member Mike Jones put forth a suggestion renaming Mill Street to Bobby Boss Drive. He stated that Bobby Boss and his wife Evelyn lived for many years in the immediate area and due to the long standing dedication from Mr. and Mrs. Boss to the City and the entire community that it would be fitting to rename the street in the honor of Bobby Boss.

Vice Mayor Curry asked City Manager Bill Jones did he want to discuss the Real Estate matter pertaining to the purchase of a piece of property on Main Street. City Manager Bill Jones stated that he has been giving information about the property located next to 254 Main Street and asked the Council if they were interested in making an offer on the property

Council member Skip Baliles made a motion to go out of executive session Mike Jones seconded.

Mark Kiddoo made a motion to go into regular session seconded by Skip Baliles.

Mike Jones made a motion it was seconded by Skip Baliles to rename Mill Street Bobby Boss Drive. In the discussion Council member Mark Kiddoo stated that he just was not comfortable with naming a street after someone who is still living.

Skip Baliles stated that he agreed with Mark Kiddoo but wanted to remind everyone that Bobby Boss had do so much for this community.


After much discussion the vote carried 3 to 1 with Mark Kiddoo in opposition.


A vote was taken and carried with all in favor.
