Regular Council Meeting
Thursday, June 12, 2014 7:30pm
Council Chambers

The Mayor and Council for the City of Loganville met on Thursday, June 12, 2014 at 7:30pm in the council chambers for their regularly scheduled council meeting. Mayor Dan Curry and Council Members Chuck Bagley, Skip Baliles, Jay Boland, Mike Jones, Mark Kiddoo and Rey Martinez were all present.

Mayor Dan Curry called the meeting to order at 7:30pm.

Dr. Henry Baldwin with the Holy Cross Anglican Church gave the invocation and Airman 1st Class Mize with the Civil Air Patrol led the pledge to the flag.

Council Member Mark Kiddoo made a motion to amend the agenda to include a presentation by Council Member Rey Martinez and an announcement by the City Council and approve the agenda. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to approve last month's minutes as presented. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to approve last month's financial report as presented. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Council Member Mike Jones made a motion to approve Case #R14-001 for the rezoning of the City of Loganville's property located at 131/135 Main Street (Rock Gym) from R-44 to CH. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

Council Member Mike Jones made a motion to approve Case #V14-003, Paran Home's request for relief from Section 119-249(3)(e) to be allowed to use Hardy Plank siding instead of brick, stone or stucco. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

Council Member Mike Jones made a motion to increase the amount of employee life insurance from \$25,000 to \$50,000. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to allow Finance Director Natalie Warnack the authority to make the necessary year-end budget adjustments. Council Member Mike Jones seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve the annual contract with Ferguson Waterworks for water and sewer materials. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

Council Member Chuck Bagley made a motion to approve the repair of the chipper at a cost of \$10,000. Council Member Mike Jones seconded the motion. Motion carried 6-0.

Council Member Chuck Bagley made a motion to allow the Mayor the authority to sign that contract with Keck & Wood for the engineering of the Brand Road intersection improvement project. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

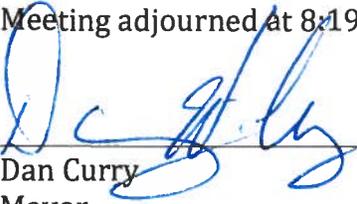
