

## MINUTES

CITY OF LOGANVILLE  
Regular Council Meeting  
Thursday, August 8, 2013 7:30pm  
Council Chambers

The Mayor and Council for the City of Loganville met for their regularly scheduled Council Meeting on Thursday, August 8, 2013 at 7:30pm in the Council Chambers. Mayor Dan Curry and Council Members Skip Baliles, Jay Boland, Mike Jones, Mark Kiddoo, Michelle Lynch and Rey Martinez were all present.

Mayor Dan Curry called the meeting to order at 7:30pm.

WQC Director Chris Yancey gave the invocation and Council Member Rey Martinez led the pledge to the flag.

Council Member Skip Baliles made a motion to remove the resolution for term limits of elected officials from the agenda and approve the agenda with this change. Council Member Mike Jones seconded the motion. Motion failed 2-4, with Council Members Jay Boland, Mark Kiddoo, Michelle Lynch and Rey Martinez voting in opposition of removing the matter from the agenda.

Council Member Rey Martinez made a motion to approve last month's minutes. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to approve last month's financial report. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to set the 2013 Millage Rate at 10.27 mils. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Police Chief Mike McHugh asked that the Mayor and Council table the purchase of an automatic tag reader system for 30 days to allow time to gather additional information regarding the system. Council Member Rey Martinez made a motion to table the tag reader system for 30 days. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to approve the purchase of two vehicles for the police department for a total cost of \$43,536.50 from Loganville Ford. Council Member Michelle Lynch seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve a change order for the Brand Road CDBG Project to install an additional 480ft 8" water line for \$46,000. Council Member Skip Baliles seconded the motion. Motion carried 6-0.


Council Member Jay Boland made a motion to approve the 2013 Mission SCADA Contract for \$11,154.60. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.


Council Member Skip Baliles made a motion to approve a resolution that would ask the General Assembly to approve a Charter Change to approve term limits within the City of Loganville. Council Member Mike Jones seconded the motion. Motion failed 2-4 with Council Members Jay Boland, Mark Kiddoo, Michelle Lynch and Rey Martinez voting in opposition.

Council Member Mark Kiddoo made a motion that the subject of term limits not be discussed again until November 2014. Council Member Rey Martinez seconded the motion. Council Member Mike Jones stated that he did not believe this motion was proper and asked City Attorney Karen Woodward for an opinion on this motion. Mrs. Woodward stated that she did not believe the motion was proper.

With no further business, Council Member Michelle Lynch made a motion to adjourn. Council Member Rey Martinez seconded the motion. Motion carried 6-0.
