The City of Loganville Mayor and Council met on Thursday, August 14, 2014 at 7:30pm in the Council Chambers for their regularly scheduled meeting. Mayor Dan Curry and Council Members Chuck Bagley, Skip Baliles, Jay Boland, Mike Jones, Mark Kiddoo and Rey Martinez were all present.

Mayor Dan Curry called the meeting to order at 7:30pm.

Utilities Director Chris Yancey gave the invocation and Airman Campbell with the Civil Air Patrol led the pledge to the flag.

Council Member Mark Kiddoo made a motion to adopt the agenda as presented. Council Member Rey Martinez seconded the motion. Motion carried 4-2 with Council Members Chuck Bagley and Skip Baliles voting in opposition.

Council Member Rey Martinez made a motion to approve the minutes from last month's meeting. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to approve last month's financial report. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Council Member Mike Jones made a motion to approve the withdrawal of Case #R14-002 by the applicant Danny Herrmann to rezone 4.76 acres from R44-R22 on Tom Brewer Road without penalty to the property owner. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to take \$30,000 from reserves to fund the Loganville Development Authority. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to approve the purchase of 5 sets of turnout gear for a cost of \$9,605. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to approve the purchase of a new vehicle for the police department at a cost of \$33,371.32. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to approve the renewal of the SRO Contract with Walton County BOE for the 2014-2015 school year. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve the annual contract with Bullseye Mapping for \$15,000. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve the annual contract with Missions Control. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

Council Member Chuck Bagley made a motion to approve amendments to the Special Event Policy adding the necessary revisions in regards to the Rock Gym. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Mike Jones made a motion to approve the 5K Run Permit for Loganville First Baptist Church. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.
