Council Member Mark Kiddoo made a motion to approve the revised GMEBS Trust and Participation agreement regarding employee health insurance. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve an amendment to the Sewer Ordinance regarding private pump stations. Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve the purchase of aerators for the water department for \$61,430.20. Council Member Rey Martinez seconded the motion. Motion carried 6-0.




With no further business, Council Member Rey Martinez made a motion to adjourn. Council Member Jay Boland seconded the motion. Motion carried 6-0.
