The City of Loganville Mayor and Council met for their regularly scheduled Council Meeting on Thursday, October 9, 2014 at 7:30pm in the Council Chambers. Mayor Dan Curry and Council Members Chuck Bagley, Skip Baliles, Jay Boland, Mike Jones, Mark Kiddoo and Rey Martinez were all present.

Mayor Dan Curry called the meeting to order at 7:30pm.

Council Member Mike Jones made a motion to remove the blight ordinance from the agenda until January and approve the agenda with this correction. Council Member Chuck Bagley seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to approve last month's minutes as presented. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to approve last month's financial report as presented. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to set the 2014 Millage Rate at 10.27. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve the purchase of a backup pump for the Chandler Haulk Life Station for \$11,715.00. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve revisions to the water and sewer ordinance as presented requiring separate and distinct water and sewer service connections for each premise located in the service territory. Council Member Mike Jones seconded the motion. Motion carried 6-0.

Council Member Jay Boland made a motion to approve the Water Loss Detection Contract with Utility Services for \$26,200.00. Council Member Mike Jones seconded the motion. Motion carried 6-0.


